- Aged and Community Services SA & NT (ACS) provides a legislation update service on a subscription basis for ACS members and non-members.

- While it is not necessary for aged care providers to have every piece of relevant legislation immediately accessible, it is useful for providers to be aware of the legislation which may impact on their operations.
